





TYP. CAMPUS MEMORIAL - ELEVATION





YP. CAMPUS MEMORIAL - ELEVATION





TYP. CAMPUS MEMORIAL - PLAN
















MEETING NOTES OF THE UNIVERSITY FACILITIES PLANNING BOARD May 7, 2013
