ITEM No. 1 – APPROVAL OF MINUTES

ITEM No. 2 – EXECUTIVE COMMITTEE REPORT

Walt Banzinger reported that the School of Architecture is temporarily storing their bridge projects under the overhang at the south side of Cheever Hall. These projects are to be removed by the end of the semester. If projects are not picked up by December 10, 2007, Work Control has index number to remove. If this is successful, the School of Architecture may consider repeating each Fall Semester.

ITEM No. 3 - ENLARGEMENT OF PLANTING BED – SOUTH 11TH AVENUE AND COLLEGE ST

Candace Mastel presented the need for enlarging the planting bed at South 11th and College Street. The planting bed is often trampled because this area is a focal point of entry into campus as well as a photo opportunity for visitors and students. Expanding the planting bed and adding rock would alleviate this. Adding rock will make it easy to stand and walk on. Concern over lighting and funding. Drummond advised that lighting would be presented at another time to the Board if needed, and that this item is for bed expansion only. Funds from O&M and will reduce maintenance costs.

Item No. 4 - LRCDP DRAFT COVER

Candace Mastel presented the draft cover concept for the LRCDP.

A key piece to the LRCDP concept is the draft cover and how it is portrayed. It captures character elements from inside the document. The front cover will have a rendering of Bozeman and the Valley.
